Considerable Points for Staying of Income Tax Demand Section 220(6) of the Income-tax Act, 1961 (the Act) provides that where the taxpayer has presented an appeal before the Commissioner of Income-tax (Appeals) [CIT(A)] under Section 246 of the Act, the Assessing Officer (AO) may, in his/her discretion, treat the taxpayer as not being a defaulter with respect to the amount in dispute in the appeal even though the time for the payment has expired, as long as the appeal is still pending for review.
